

Terms and Conditions for TCS London Marathon 2026

By accepting a place from Scleroderma & Raynaud's UK (SRUK) in the TCS London Marathon 2026 the Participant agrees to the following terms and conditions:

Defined Terms

“Event” means the TCS London Marathon 2026 to be held on Sunday 26th April 2026.

“Event Organiser” means the organiser of the TCS London Marathon 2026.

“Participant” means a runner with an SRUK charity place for the TCS London Marathon 2026

Participation

1. The Participant will inform SRUK's Community and Events Team immediately if they are unable to take part in the Event (the Participant must inform SRUK by no later than February 2026 (the exact date will be specified by the organisers and to all runners once officially registered) as this will enable SRUK to find a replacement runner).
2. The Participant must also register directly with the Event Organiser on the online event console (*Let's Do This*) by the deadline set by the Event Organiser. SRUK reserves the right to withdraw the place of the Participant if they have not registered with the Event Organiser in accordance with this condition and to offer their place in the Event to another applicant.
3. The Participant understands that the Event is organised by the Event Organiser who is solely responsible for the conduct and operation of the Event, including all health and safety requirements. Please see the Event Organiser's terms and conditions or contact the Event Organiser directly for more information about the Event and the potential risks involved.
4. SRUK is not responsible for the Event and accepts no liability whatsoever in relation to participation by the Participant. SRUK does not accept any responsibility for any injury, loss or damage incurred during participation in the Event. The Participant enters the Event at their own risk and take full responsibility for own actions prior to, during and after the Event. If the Participant has any concerns about his or her physical condition, they are advised to consult their doctor before taking part in the Event.

5. The Participant understands that their offer of a place is to run in the Event only on 26th April 2026. Should the Event be cancelled and not rescheduled in 2026, SRUK is under no obligation whatsoever to transfer the Participant's place to a future date for the London Marathon.

Donations and Payment Terms

6. The Participant pledges to raise the minimum sponsorship target of **£2500** [excluding Gift Aid and the registration fee] for the Event
 - a) The Participant agrees to ensuring their donations meet the minimum requirements to the following deadlines:
 - i) At least £600 to be raised before 1 December 2026
 - ii) At least £1200 to be raised before 26 February 2026
 - iii) At least £2000 to be raised before event day
 - iv) Total of £2500 to be raised at least 6 weeks after event day (7 June)
 - b) SRUK will support the Participant throughout their fundraising process, and will be on hand to discuss any issues or concerns with the above. All Participants will have regular contact from SRUK.
 - c) SRUK reserves the right to remove the Participant from the Event if they do not meet the deadlines above, and/or do not communicate with SRUK regarding their fundraising.
7. The Participant will inform SRUK's Community and Events Team immediately if they believe they will not be able to fulfil the sponsorship pledge.
8. All fundraising activity undertaken as part of the Event must be for the benefit of SRUK only.
9. The Participant will endeavour to raise as much as possible for SRUK and will regularly pay all money raised to the charity by:
 - i) Using only one of our preferred fundraising platforms, either justgiving.com or enthuse.com (payouts to SRUK are made automatically by the online platforms)
 - ii) Sending cheques made payable to "Scleroderma & Raynaud's UK" to Scleroderma & Raynaud's UK, Bride House, 18 – 20 Bride Lane, London, EC4Y 8EE – with reference to your London Marathon fundraising

- iii) Calling the Community and Events Team on 020 3893 5998 to pay over the phone with credit or debit card details
- iv) Paying online via the SRUK website: www.sruk.co.uk/donate with debit or credit card

10. The Participant will send all outstanding sponsorship money to SRUK as soon as possible after the Event, and understands that if the minimum fundraising target has not been met, then it is their responsibility to ensure the full amount is paid in before 7 June 2026.

Fundraising activities

11. The Participant will comply with any fundraising guidance or advice issued by SRUK (in accordance with the Code of Fundraising practice issued by the Fundraising Regulator), using only lawful means to fundraise and will not do anything that is likely to harm SRUK's reputation.
12. The Participant will use SRUK's fundraising materials to fundraise for this event.

Personal data

13. The Participant agrees for personal information to be stored and used by SRUK in connection with the organisation, promotion and administration of the Event and passed on to the Event Organiser as required – in accordance with GDPR policies.

Acceptance of these Terms and Conditions

14. Declaration:

- i) By registering with SRUK to participate in the Event, the Participant agrees to be bound by these Terms and Conditions.
- ii) If any provisions in these Terms and Conditions, whether in full or in part, is held to be invalid or unenforceable, all other remaining provisions (in full or in part) shall continue to be valid and enforceable.
